Download 1 HOBOmobile® to your phone or tablet.





- Install the batteries in the logger. Open the battery door on 2 the back of the logger and insert two AAA batteries observing polarity. Reinsert the battery door and snap it back into place.
- Open HOBOmobile. Enable Bluetooth® in your HOBO device settings if prompted.
- 4 In HOBOmobile, tap HOBOs. The logger should appear in the Recently Seen/In Range list shown in step 5. If the logger does not appear, make sure the logger is within range of your
- Tap a row in 5 RECENTLY SEEN / IN RANGE the Recently SN 47002616 Seen/In Range list to Stopped (Power Reset) connect to 77.60°F 57.08% the logger.
- √ HOBOs Once 6 SN 47002616 connected, tap Configure to set up and start the logger. Configure
 Set up and star
- Choose your logger settings and then tap Start in the upper 7 right corner of the Configure screen. The logger will begin logging data based on the settings you selected.



- Deploy the logger using the magnets on the back of the logger 8 case or the mounting materials included.
- To offload data from the logger to your device, connect to it 9 and tap Readout (shown in example in step 6). The data from

the logger is saved to your device. Tap Data Files and then tap the mini-graph to view a larger version of the graph or to share the file.
